4. WORKSHOP SESSION - ITEM FOR DISCUSSION ONLY


(a) *Discuss the selection criteria for the City Manager's position due to the resignation of the former City Manager*

Mayor and City Council also discussed the Pro's and Con's of using a search firm to hire a new city manager.


5. ADJOURN
